

SELCO Small Business Week Giveaway
Official Giveaway Rules
May 3-9, 2021

Important: Please read these rules before entering SELCO's "**Small Business Week Giveaway**" (the Giveaway). By entering the Giveaway, you agree to be bound by these Official Giveaway Rules and represent that you satisfy all eligibility requirements.

1. **Giveaway Period:** Giveaway entries shall be accepted May 3 – 9, 2021. Ten (10) winners will be selected from the entrants on May 10, 2021.
2. **Eligibility: Facebook and Instagram followers 18 years or older who have liked and commented on the Small Business Week Giveaway post as of May 9, 2021 are eligible to enter.** SELCO and SELCO subsidiary company employees, officers, representatives, and their immediate families or household members, and anyone connected with the production and distribution of this giveaway are not eligible to enter or be awarded a prize.
